- PLACE MEMBERS SUE THE BOARD OVER SPECIAL ASSESSMENT FOR NOT HAVING COVERAGE Z

- WORD DOES GET AROUND QUICKLY. **AMONG** AGENT ASSOCIATION CLIENT SUFFERS LOSS OF CONFIDENCE BASE SINCE
